## GENERAL DISCUSSION

## Miscellaneous

Chairman Mike Mathews stated that there are currently three board vacancies. Recently Vice-Chairman Mark Baker and Ms. Denise Sullivan resigned from the board.

## 2018 Bond Referendum Campaign Discussion

Mr. Tom Gardo with The Denarius Group gave an update on the campaign for the 2018 Bond Referendum that will be voted on this November.

## **TDR (Transfer of Development Rights)**

Mr. Eric Greenway stated that the only sending area for the TDR is within the AICUZ (Air Installation Compatibility Use Zone). However a receiving area has yet to be identified. Mr. Greenway felt that this program would not be useful to the Rural and Critical Land Preservation Program.

#### South Carolina Conservation Bank

Ms. Barbara Holmes stated that the South Carolina Conservation Bank has been around since 2002 as an alternative funding source. It was decommissioned for a while but came up for reauthorization this year. A new feature is the ability for counties and municipalities to request funding from the bank.

## Passive Parks Comprehensive Plan/Ordinance

Ms. Stefanie Nagid presented her passive parks comprehensive plan and ordinance to the board members. She requested any comments or feedback to be sent to her email account. She presented these plans to the Planning Commission and will be sending it to the Natural Resources Committee and County Council for approval.

## **RCLP Program Policies and Guidelines Resolution Revisions**

Ms. Nagid and Ms. Holmes met and reviewed the 2006 RCLP Program Policies and Guidelines Resolution for board members and decided that it needed to be updated. The board requested to have more time to review the revisions. This item will be on next month's agenda.

## CALL TO ORDER AND WELCOME GUESTS

Chairman Mike Mathews called the meeting to order at 3:03 p.m.

## **EXECUTIVE SESSION**

Chairman Mathews entertained a motion by Ms. Gail O'Kane, seconded by Mr. Beekman Webb, to adjourn the Open Session at 3:05 p.m. and convene Executive Session. **The motion carried unanimously to enter into Executive Session** (FOR: Mathews, Walls, Hill, Webb, O'Kane, Mack, Bender, Koop). The Executive Session was called for the purpose of discussing

contractual matters between the Rural and Critical Lands Preservation Board / Beaufort County Land Exchange.

Chairman Mathews entertained a motion to adjourn the Executive Session and reconvene the Open Session at 3:52 p.m. There were no matters arising out of Executive Session.

## **REVIEW OF AGENDA**

Chairman Mathews asked if there were any changes to the Agenda, and there were none.

## **REVIEW OF MINUTES**

Chairman Mathews asked if there were any changes to the Minutes from the August 9, 2018, R&C Board meeting. Ms. Gail O'Kane requested that the Adjournment section be revised as follows:

"After two motions relating to the business from the Executive Session failed due to a lack of a second, and the time being after the usual 5:00 p.m. ending time, a board member left which made for an insufficient quorum so the meeting was adjourned at 5:02 p.m."

Ms. O'Kane also stated for the record that she never asked for a change to the August 9, 2018, minutes without a vote.

Five (5) R&C Board members were present at the August 9, 2018, meeting, Mathews, Fripp-Gordon, Mack, O'Kane, Scanlin. Three (3) of the five (5) Board members are present today to vote on the requested change to the Adjournment section of the August 9, 2018, meeting minutes, Mathews, Mack, O'Kane. Therefore, Ms. Gail O'Kane made a motion and Chairman Michael Mathews seconded the motion to revise the Adjournment section of the August 9, 2018, meeting minutes to read as noted above. The motion carried unanimously (FOR: Mathews, O'Kane, Mack).

Chairman Mathews asked if there were any changes to the Minutes from the December 13, 2018, Board meeting. Hearing none, Mr. Beekman Webb made a motion and Mr. Douglas Koop seconded the motion to accept the minutes as written. The motion carried unanimously (FOR: Mathews, Walls, Hill, Webb, O'Kane, Mack, Bender, Koop).

## **2018 ANNUAL REPORT**

Ms. Barbara Holmes presented the 2018 Annual Report to the Board members. She discussed the Economic Benefits Report, \$25M Bond Referendum, cumulative program statistics, and status of Rural and Critical Lands Preservation protected properties. In 2018, forty-seven (47) properties were considered for acquisition. Of those forty-seven parcels, four (4) were brought before the Board for consideration, and three were recommended by the R&C Board. Two of the four approved property acquisitions closed in 2018, 4.16 acre Okatie Highway Island, part of the Greenway Corridor, and 9.72 acre Whitehall Tract, Lady's Island/City of Beaufort. The other two properties are scheduled to close in 2019. Note: The Whitehall Tract acquisition was not recommended by R&C but was presented at the Natural Resources Committee meeting and approved by Beaufort County Council.

There was a general consensus amongst the R&C Board members to submit the 2018 Annual Report, as written with no revisions, to the Natural Resources Committee for review at their upcoming 2019 meeting before being presented to Beaufort County Council.

#### RURAL AND CRITICAL LANDS PRESERVATION BOARD PROGRAM OVERVIEW

Ms. Barbara Holmes distributed and discussed the R&C Program Manual, referencing the following sections:

Chairman Mathews stated that updates to the R&C financials would be presented to the Board on a quarterly basis.

Ms. Holmes reminded all meeting attendees about the interactive protected land maps managed by the Open Land Trust and available to the public for viewing purposes. Ms. Stefanie Nagid stated that all R&C lands can also be accessed at the Beaufort County web site, Home page, GIS Map.

## **GREENPRINT DISCUSSION**

Chairman Mathews stated that the Greenprint map will be updated in 2019. Ms. Holmes feels that revisions to the R&C Lands Criteria should occur first in order to become more informed when updating the Greenprint, and she feels it could take up to one year to complete the necessary revisions before presenting to Beaufort County Council. Both Chairman Mathews and Ms. Holmes stressed the importance of future public stakeholder meetings in order to encourage more public involvement regarding planning and Greenprint updates for each district.
